COURSE OBJECTIVES

Through interactive lectures, case studies, discussions and practical exercises participants will delve into the complexities of human rights issues and learn how to advocate for positive change in their communities and beyond.

- 2. Gain knowledge of the historical development of human rights and key international human rights instruments and mechanisms.
- 3. Explore the different categories of human rights including civil and political rights, economic, social and cultural rights as well as collective rights.
- 4. Develop awareness of contemporary human rights issues and challenges including gender equality, refugee rights, minority rights and LGBTQ + rights.
- 5. Learn about human rights violations, abuses and mechanisms for monitoring, reporting and redressal.
- 6. Understand the role of civil society, NGOs, government and international organizations in promoting and protecting human rights.
- 7. Explore strategies for building partnerships, networks for effective human rights advocacy and action.

COURSE OUTCOMES

- 1. Analyze human rights issues and violations from a multidimensional perspective, considering legal, social, political and cultural factors.
